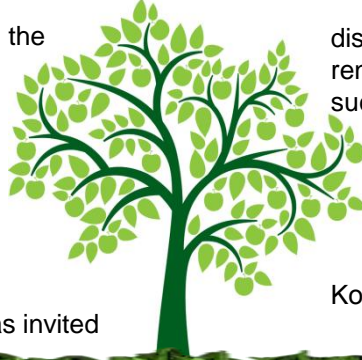


## “The Way to Become a Top Trainer II”
