The PMP® Certification Test Preparation Course

Introduction

The three-day PMP® Certification Test Preparation Course covers all the key content of the Project Management Body of Knowledge, PMBOK™ (3rd Edition) by PMI. This includes the Project Management Framework which provides a basic structure for understanding project management; the Project Management Context: the environment in which the projects operate; the Five project management processes (namely Initiating, Planning, Execution, Monitoring and Controlling and Closing) and their interactions; and the nine Knowledge Areas (Project Management Integration, Scope, Time, Cost, Quality, Human Resource, Communication, Risk and Procurement Management) which are explained along the core and facilitating processes. Above this, the course would also cover the Professional Responsibility, provide Examination Hints and Tips, Sample Test Questions and Answers, as well as guidelines on Logistic and Administrative Preparation for the Examination.

The PMP® Certification Test Preparation course prepares the participant to pass the Project Management Professional examination. This course is in complete compliance with the Project Management Institute (PMI) Guidebook, the Project Management Body of Knowledge, PMBOK™. The course will earn 27 PDUs towards PMI Certification. A total of 35 PDUs is required to meet examination entry requirements.

This course provides experienced project managers with the tools and tips for passing the examination. It includes 50-60 "Examination Tips" of questions that always seem to appear on the test in some form. The course includes several hundred exam questions, and during the course, the participant will take at least four (4) hours of timed examination under conditions similar to the actual exam.

Who Should Attend

This course is targeted at experienced project managers interested in passing the PMI Project Management Professional (PMP®) examination through a combination of lectures, test examples, "exam tips", actual timed tests, and independent study.

The Course Goals

The broad learning goals of the PMP® Prep Course include:

- Provide a framework for structuring the Project Management Body of Knowledge;
- Identify the most generally accepted practices within the discipline of project management;
- Pass the PMP® Certification Examination

Participants are required to bring along a non-programmable basic 5-function Calculator to the workshop to assist them in attempting the sample test questions that required calculation.
