The fee is a composite fee including:

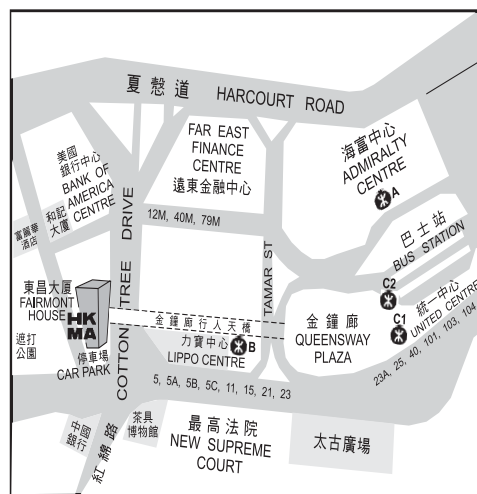
- Registration with the University
