A. Application Procedures

1. Please read the brochure carefully before filling in the Application Form.
2. Return the completed Application Form, together with 2 Photos and a crossed cheque for HK\$250 made payable to "The Hong Kong Management Association" for the non-refundable Application Fee to The Hong Kong Management Association, 16/F, Tower B, Southmark, 11 Yip Hing Street, Wong Chuk Hang, Hong Kong before the deadline for application.
3. The Application Form must be accompanied by 2 sets of copies of educational qualifications (academic transcripts and certificates) and any other proofs to support your application (e.g. testimonials of working experiences). Please note that an incomplete application will cause delay in processing.

B. Enrolment Procedures

1. The HKMA-UNICE DBA and MBA Secretariat will notify the applicants by letter or e-mail upon receipt of the application.
2. Applications will be assessed by, and admission decisions will be made at the discretion of the University of Nice Sophia-Antipolis and CASS Europe.
3. Tuition fee payment is due at a specified date before the commencement of the semester.
4. Successful applicants will be required to produce their original copies of credentials for verification at the time of registration.

F. Tuition Fees and Other Fees

1. Upon enrolment, students can take 3 to 4 years (respectively for direct entry to DBA and for entry to DBA through the MBA path) to complete their program(s) of study. They may pay their tuition fees every 6 months according to the following instalments:

(All enrolled students will be notified by letter or email on payment of tuition fee details).

2. The fees described above will include all study materials provided by the University but exclude recommended textbooks (one per subject), and Project / Thesis supervision.

G. Time-table and Venue

There will be 5 semesters over a span of 3 years for the DBA and 6 semesters over 4 years for the MBA + DBA. DBA students will spend approximately 6 months to complete their course work first and then 30 months to the thesis stage. For students taking the special MBA prior to taking the DBA, they will spend an additional 12 months for the MBA coursework. Students will be notified of details of the time table and venue in due course.
