A. <u>Enrolment Procedures</u>

- 1. Please refer to the Time-table before completing the Enrolment Form.
- 2. Return the completed form(s), together with a crossed cheque in favour of The Hong Kong Management Association for Module Fee (HKMA Member: HK\$2,850 per module; Non-member: HK\$2,980 per module) no later than 30 December 2019.
- 3. Please write your FULL NAME and HKID CARD NO. on the back of the cheque.
- 4. A receipt will be issued against payment.

B. Application for Exemption

A completed application form, together with copies of testimonials such as certificates and transcripts, must be submitted to the Secretariat before the course commencement date. An exemption fee of HK\$250 per module will be charged. Applications will not be accepted after the course has commenced.

C. Refund of Module Fee

- 1. Full refund less the HK\$490 HKMA one-year membership fee for 2020 (if applicable) will be made for written withdrawal requests received prior to 30 December 2019 by the PDPF Secretariat.
- 2. Refund of module fee less the HK\$200 cancellation charge per module and the HK\$490 HKMA one-year membership fee for 2019 (if applicable) will be made for written withdrawal requests received before 21 December 2019. Thereafter no refund will be made.
