SEMINAR OBJECTIVES

INTRODUCTION

Many corporations which collapsed and wiped out billions of dollars from investors were triggered by fraudulent transactions, financial wrongdoings and commercial crimes. Frauds of various kinds may be hidden inside the jungle of accounting books and records. Financial statements seek to reflect corporate status and performance, but their integrity may become questionable due to accounting irregularities. Manipulation of accounting data, misstatement of assets / liabilities, distortion of revenue / expenditure and misrepresentation of financial disclosure are all examples of accounting irregularities. This executive workshop will take participants to an unseen world of accountancy revealing the truth beneath accounts and financial statements.

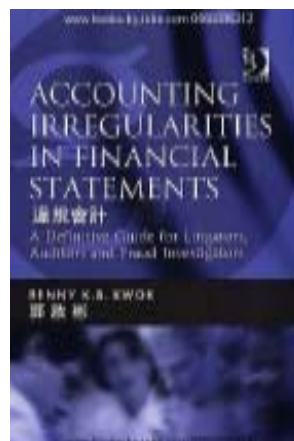
