Candidates are required to send the followings:

- Two (2) sets of duly completed Application Form. (One original set and one photocopy)
- Two (2) sets of photocopies of all certificates of educational qualifications mentioned in the Local Assessment Form, including a full transcript with grades for relevant level qualification.
- One (1) passport sized photograph.
- Documentary proof of proficiency in English, where applicable, e.g. Result slip of IELTS with overall band score at 6.5 or above.
- A non-refundable application fee of HK\$250 (Cheque should be made payable to "The Hong Kong Management Association".)

#### 4. PROGRAMME FEE

The total programme fee is HKD 83,400 to be collected in three (3) instalments, according to term of study.

The fee is a composite fee including the followings:

- Registration with the University
- Induction Seminar
- Seminars
- Local study group
- Access to library facilities
- Study notes and essential textbook(s)
- Local administrative support

Student should note that all fees are subject to review and may change by the University.

#### 5. PROGRAMME STRUCTURE

The LL.M Programme can be completed in 12 months over three academic terms. Each term lasts for 18 weeks. The maximum length of completing the programme is in 36 months. Students are required to achieve 180 credits for completing the Programme, which consists of six modules including a dissertation. A supervisor will be assigned to students to maintain close contact with students and to provide professional advice.
